### Agenda 108: PCC planning notices

1. P/2016/0983 – Proposed Residential Development for up to 9 dwellings and creation of new access and associated works on land south of Maes Castell SY21 9BJ

Cllr JH sent in message there may be drainage problems. Plans outline a mix of semi-detached and detached properties. Cllr EO raised increase in traffic however indications are that Highways seem ok with it presently. Cllr GH proposed in favour, Cllr MJ seconded, carried unanimously.

2. P/2016/0959 – Proposed land at Swallows Meadow Castle Caereinion SY21 9DZ – Application for outline planning permission for erection of 5 dwellings with some matters reserved

Cllrs agreed this was a very important issue for the whole village.

Cllr JH noted there is an indication of landscaping on the plans.

Clear some residents were not expecting the development. Section 106 discharge grant was included within Council minutes in Nov 2014. Some Cllrs were of the opinion letters would have gone out to residents before this (approx. 2011), but aware people had moved into area since then.

Concern about increased traffic in Swallows Meadow, as there has already been a problem.

Use of land as a potential play-area was discussed, general consensus there were insufficient funds to maintain the land. Cllrs were of the opinion there was no plan to provide a play area on the original plans for the first 55 dwellings, retrospectively this would have probably been the best option, but have to judge on the plans at present.

Cllr EO stated there must be a reason the original plans were for 55 and not for 60.

Cllr JH stated community centre green area was available for children and young people, providing dogs were not brought on.

Cllr NB stated as LDP not adopted and UDP has expired, he was concerned the plans may go through anyway, this could be an opportunity to use the planning application as leverage to construct traffic calming measures and we could support the plan with conditions.

Cllr GD proposed the council votes against the plans, EO seconded.

Cllr JH proposed an amendment that the Council accept the plan on the condition the builder includes traffic calming measures up to the latest road safety standards to safeguard residents in Swallows Meadow. Seconded by Cllr GH - Amendment was carried by majority to support the planning application.
